5 year warranty: BOGE best*cair* is intended to extend the warranty on your compressed air supply beyond the regular period of twelve months. Contact your service partner or the BOGE ServiceCenter for more details on the advantages of BOGE best*cair*!



BOGE best*cair* is designed to secure an extended 5-year factory warranty on new compressed air stations equipped with oil injected screw compressors.

The following components are covered by the best*cair* warranty

- Compressor air end
- Main drive motor

(\* if installed)

- Frequency converter\*
- Oil cooler and re-cooler of air cooled compressors
- Combined receiver
- Compressor control
- Basic frame
- Coupling\*

- Built-in dryer
- Pipe work
- Fan motor
- Valve housing

best*cair* WARRANTY CONDITIONS

- The new compressor station is to be installed, connected and operated in accordance with the BOGE operating instructions.
- A fully completed commissioning report for your machine is to be presented within the first six months after delivery (according to delivery note date) and/or after max. 500 operating hours.
- · All maintenance intervals are to be adhered to in conformity with the operating instructions. The prescribed maintenance intervals may be exceeded once only by 10 % (300 operating hours).
- The compressor is to be exchanged no later than after 30,000 operating hours.
- The bearings of the electric motors in ≤ 22 kW machines are to be replaced no later than after 10,000 operating hours, and in ≥ 22 kW machines no later than after
   20,000 operating hours
- All maintenance work is to be carried out in accordance with the operating instruction and replacement parts manual including the pertaining maintenance and wear part. It is imperative that only genuine BOGE parts and/or the respective cairpacs be used.
- · Only the BOGE 3000 plus or BOGE SYPREM 8000S
- · All maintenance work is to be exclusively carried out
- by BOGE service or BOGE authorized bestcair partners.
- All servicing reports and invoices are to be saved by customers or service partners for any potential warranty claims.

### best*cair* WARRANTY EXCLUSION

- BOGE reserves the right to replace any defect components or to insist on their replacement if such measure is liable to prevent any serious damage.
- · It is at BOGE's discretion to determine whether the parts to be replaced are equivalent, overhauled, or new.
- Any exchanged parts of the A category are the property of BOGE. Unless otherwise agreed, such parts are to be returned to BOGE within 30 workdays after occurrence of damage. Return shipment of parts of the B and C categories are to be effected at BOGE's request only.
- The warranty on any exchanged parts shall in no case be extended beyond the expiry of the best**cair** warranty
- Any rented or relief machines which are not permanently installed do not qualify for the bestcair program. In case of a change of the compressor location or sale of the compressor station during the bestcair warranty period, it is imperative that BOGE be informed accordingly and that a new commissioning report is issued.
- Any compressor station having been converted and/or modified by a third party shall be excluded from the best**cair** program
